<b>Subject goal</b> <p>The programme aims to provide a firm understanding of contemporary economic and social processes and tendencies that shape the global world and their gendered outcomes. This interdisciplinary programme focuses on recognising gender dimensions of economic globalisation and neoliberal transition and their impact on gender equality and position of women.</p>
<b>Outcome of the subject</b> <p>After completion of this programme, students are able to: understand gender issues in a global and transnational context; to recognise and describe gender dimensions of various issues related to globalisation; to critically judge policies and issues related to structural adjustment programmes, transition and neoliberal macroeconomics and their impact on women and gender equality; to recognise how inequalities, poverty, vulnerabilities and gender intersect; to formulate own research questions in the field of globalisation and gender; to implement research methods for theoretical and empiric research in the field of globalisation and gender; to write an academic paper on the issues.</p>
